Project Description, Justification and Location

This project will replace sections of deteriorated sidewalks and curbs and gutters in identified areas of Spartanburg County. In FY 2007/08, \$25,000 was budgeted to complete an inventory of County sidewalks and develop needs assessment. In FY 2009-2013, \$150,000 is budgeted annually to complete approximately one (1) mile of sidewalks.



Benefits to Residents, Visitors, Businesses, or County Employees

This project will improve safety to pedestrians, promote active lifestyles, and enhance the appearance of the areas where the sidewalks have been rehabilitated.

Impact on Annual Operating Budget

Annual maintenance costs the first five years after rehabilitation will be minimal.

Project Status (as of June 1, 2008)

Active project. Delay in project pending revisions to the sidewalk inventory. Revisions scheduled to be completed in the summer of calendar year 2008, with a plan to begin repairs to follow.

Project Description, Justification and Location

This project will provide funding for infrastructure associated with alternative transportation needs (walking, biking, transit, etc.) Opportunities will be identified by the County and strategic partnerships with community and neighborhood associations will be formed. These partnerships will allow the County to provide neighborhood connectivity, as well as connectivity to schools shopping and other needs.



In FY 2008/09, \$165,000 is proposed to be allocated to the Westside Neighborhood Association for completion of the Wadsworth Trail, a walking and biking trail in the unincorporated area of Spartanburg County west of the City of Spartanburg. The \$165,000 County contribution will be matched by a private grant to provide full funding for the project.

Benefits to Residents, Visitors, Businesses, or County Employees

Benefits of this project could include improved road safety, decreased traffic congestion, improved air quality, and improved community health.



Impact on Annual Operating Budget

Annual operating budget impact will be minimal.
