APPLICATION INSTRUCTIONS

1. State law requires that all Notary Publics be a **current** registered voter in the county of residence.
2. Carefully **TYPE** or **PRINT all** information requested in the top portion of the application and have your signature notarized. (Only original applications can be processed.)

Please note: If your address has changed since you registered to vote, it will be necessary to change your address at the Voter Registration Office (142 South Dean Street).

Please include the name of your Voting Precinct, House and Senate District Number. If you do not know your House and Senate District Number, you may call Voter Registration (864-596-2549) to obtain this information.

3. Delegation signatures, required at the bottom of the application, will be secured for you once the completed application is received in the Delegation Office.
4. Attach a Check or Money Order made payable to the Secretary of State in the amount of \$25.00.

6. Appointment papers (certificate and pocket card) will be issued to you in approximately 6 to 8 weeks.
7. Once you receive your appointment papers, take all appointment papers to the Clerk of Court's Office at the Spartanburg County Courthouse (180 Magnolia Street) to register as a notary. There will be a \$5.00 registration fee payable to the Clerk of Court.

NOTE 1: New and renewal applications must be registered at the Clerk of Court Office.

NOTE 2: You do not receive a notary seal with your appointment papers. Your Notary Seal and/or stamps may be purchased from an office supply or mail order company.
